JICA COUNTERPART TRAINING PROGRAM REQUIREMENTS

- a) Original copy (blue copy) of the typewritten duly accomplished JICA A2A3 Form
- b) Original copy of the results of the physical and medical examination (urine, blood, stool, x-ray, ecg) from DOH deputized government hospital/s or physical examination center/s and a certificate of fitness to travel physically and mentally, signed by the attending physician with license number indicated
- c) Original copy of the Statement of Actual Duties and Responsibilities
- d) Original copy of the Service Record
- e) Recently issued certificate of no pending administrative or criminal case

Note:

- ❖ Kindly forward to JICA all the requirements stated above together with the official endorsement letter from the nominating agency not later than two (2) weeks upon the receipt of the original A2A3 forms.

GOPs REQUIREMENTS WHEN ACCEPTED TO THE TRAINING PROGRAM

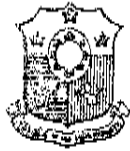
- A) For securing New Official Passport (red) at DFA:
 - 1) two (2) passport application forms
 - 2) two (2) passport size photos
 - 3) birth certificate (registered/authenticated by NSO)
 - 4) original & a photocopy of Travel Authority
 - 5) Scholarship/Training Contract between the agency and the trainee
 - 6) service record
 - 7) certificate of no pending administrative charges
 - 8) Letter of JICA acceptance

- B) For participants with existing red passport, revalidation is necessary at DFA. Requirements for revalidation are stated in A) 4-8 above.
